NOTIFICATION

LEGAL METROLOGY ACT, 2009.

No. LMO-2017/458/CR-115/CP.-3.—In exercise of the powers conferred by sub-section (1) and (2) of section 53 of the Legal Metrology Act, 2009 (1 of 2010) and of all other powers enabling it in that behalf and after consultation with the Central Government, the Government of Maharashtra hereby makes the following rules further to amend the Maharashtra Legal Metrology (Enforcement) Rules, 2011, the same having been previously published as required by sub-section (4) of said section 53 of the said Act, namely :—

(1) *Short title.*—These rules may be called the Maharashtra Legal Metrology (Enforcement) (First Amendment) Rules, 2018.

(2) They shall be deemed to have come into force with effect from the date 20th April 2018.

(3) In rule 14 of the Maharashtra Legal Metrology (Enforcement) Rules, 2011 (hereinafter referred to as “the principal rules”), in sub-rule (4) for the word “rupees twenty” the word “rupees forty” shall be substituted.

(4) For Schedule IV, V and VI appended to the principal rules the following Schedule shall be substituted, namely :—
